Scrimmages will be arranged between teams who are not scheduled to meet each other in Rounds 1, 2, or 3 of the State Bar's regional competitions, although our ability to do that will be determined by the teams that register.

Second Round: 11:45 AM

Recognition will be given to Teams with best total performances!

Fee: \$95.00 per team to cover expenses for ten team members. (same as last year)
The first 24 teams registering (with payment received) will be accepted. In the event of an uneven number, the last team registered will be given a bye. We will do our best to notify the team in advance. If you can provide at least one attorney/coach to judge scrimmages, it would be very helpful. *(If you bring two teams, you must provide at least one attorney to judge another team.)* We will provide lunch.

Dear Mock Trial Colleague,

You are invited to participate in Apollo's 17th Annual Mock Trial Invitational. We hope you will consider joining us on Saturday, January 7th, 2012 for this event.

As noted on the included "poster" announcement, scrimmages will be scheduled between teams who are not scheduled to meet each other in Rounds 1, 2, or 3 of the State Bar's regional competitions based on information from the Minnesota State Bar. Additionally, the Stearns-Benton Bar Association will attempt to ensure that attorneys volunteering to judge scrimmages that day will not be the judge for your teams' regional competitions. Many of the attorneys participating *will* be judges for the regional competition, and will be better informed because of this day of scrimmages. We would encourage your attorney coaches to participate as well.

The **First Round** is scheduled for 9:00 AM, and the **Second Round** for 11:45 AM. *Recognition will be given to teams with best total performances!* Fee: \$95.00 per team (same as last year) to cover expenses including lunch for ten team members. If there are more than 10 members, lunch can be purchased for \$6 on day of Invitational. The first 24 teams registering (with payment received) will be accepted. If you can provide at least one attorney/coach to judge scrimmages, it would be *very* helpful. (In this economy, the local attorneys are very busy with their paying clients.) *(If you bring two teams, you must provide at least one attorney to judge another team during each round.)* The registration form is reproduced below. (Please note Robin Marthaler's name on the envelope when you mail your registration – so that it arrives quickly in the right place.) Confirmations will be sent by e-mail.

We will again be providing "all you can eat" *Mexican Village* hard & soft-shell tacos, and taco salads for lunch (vegetarian option available). Beverages will be provided. Please note on the registration the number of vegetarian meals for team.
